Rob Tonn made a motion to approve February 2020 minutes. Susanne Austin seconded the motion. Minutes approved.

Treasurer - Rob Tonn

Discussion: Current report submitted and approved by all. See attached report. Year-end cash balance is \$48,637 with \$33,100 of that reserved for the balance of scoreboard commitment. Available cash balance of \$15,537 does NOT include the \$6,800 from Graduation Raffle held in Paypal account pending a decision regarding a live graduation event later this summer. No April income. Spiritwear - December bill \$4400 paid. Scoreboard - initial payment \$6900 - committed \$40,000,

Action:

Owe \$33,100 on Scoreboard commitment, but decisions still need to be made regarding how Boosters will be reimbursed for this \$40,000 commitment. Payback terms for scoreboard advertising, etc. are all elements that need to be finalized before the remaining \$33,100 will be paid.
